PROCESS

1. Combine Phase A ingredients and heat to 90°C with moderate propeller agitation. Mix for 20 minutes.
2. Combine Phase B ingredients and mix at 80°C with moderate propeller agitation. When Phase B is completely mixed, add slowly to Phase A with rapid propeller agitation.
3. Cool to 75°C and add Phase C components. Transfer to container(s) while still hot and fluid. Allow time to cool to room temperature.

This formula provides flexible control to your hairstyle while leaving hair shiny and conditioned. **Floraesters 15**, **Floraesters 20**, and **Florasun 90** contribute to emolliency, shine, and conditioning.
