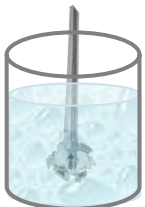
When to use Satiaxane™ VPC 911?

- When requiring to suspend particles (exfoliating or decorative beads, pigments...)
- When looking for sprayability

Formulation tips

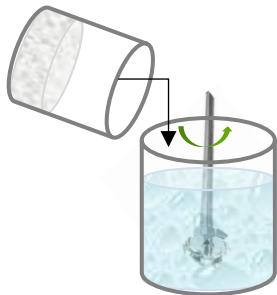
1 Prepare the water phase

Recommended: premix of the Satiaxane™ VPC 911 and the glycols is optional but it can help to speed up the process and to avoid lumps or fish eyes

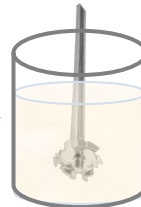


Demineralized Water

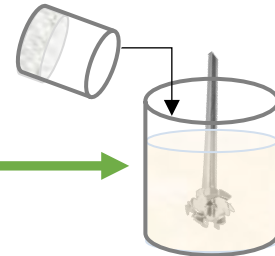
2 Slowly sprinkle the Satiaxane™ VPC 911
